

#### AMENDED ARTICLES OF INCORPORATION

#### OF MILLER COVE PROPERTIES ASSOCIATION

(HEREINAFTER, "MILLER COVE PROPERTY OWNERS ASSOCIATION, INC.")

In compliance with the requirements of the State of Arkansas, and the Arkansas Nonprofit Corporation Act of 1993, Ark. Code Ann. § 4-33-101 et. seq., the undersigned, all of whom are residents of Saline County, and all of whom are of full age, have voluntarily associated themselves together for the purpose of amending the Articles of Incorporation of the Miller Cove Properties Association (hereinafter, "Miller Cove Property Owners Association, Inc."), to hereby read as follows:

#### ARTICLE I

The name of the corporation is the Miller Cove Property Owners Association, Inc., hereinafter called the "Association".

#### ARTICLE II

The principal office of the Association is located at 608 Miller Cove, Benton, Arkansas 72019.

#### **ARTICLE III**

Angela Rutherford, whose address is 608 Miller Cove, Benton, Arkansas 72019, is hereby appointed the registered agent of this Association.

# ARTICLE IV PURPOSE AND POWERS OF THE ASSOCIATION

This Association is a public benefit corporation, and does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are to provide for maintenance, preservation and architectural control of the residence Lots and Common Areas within that certain tract of property described as:

Miller Cove, an Addition to the City of Benton, Saline County, Arkansas,

and to promote the health, safety and welfare of the residents within the above described property and any additions thereto as may hereafter be brought within the jurisdiction of this Association for this purpose to:

- (a) exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions, hereinafter called the "Declaration", applicable to the property and recorded in the Office of the Circuit Clerk and Recorder of Saline County, Arkansas, dated July 14, 1992, filed for record July 15, 1992, and recorded in Book 361 at Page 265 of the Records of Saline County, Arkansas and as the same has or may be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length;
- (b) fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association;
- (c) acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- (d) borrow money, and with the assent of two-thirds (2/3) of the members mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (e) dedicate, sell or transfer all or any part of the Common Areas to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has been signed by two-thirds (2/3) of the members, agreeing to such dedication, sale, or transfer;
- (f) participate in mergers or consolidations with other non-profit corporations organized for the same purposes or annex additional residential property an 'Common Areas, provided that any such merger, consolidation or annexation shall have the assent of two-thirds (2/3) of the members;
- (g) have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Arkansas by law may now or hereafter have or exercise.

#### ARTICLE V MEMBERSHIP

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot which is subject by covenants of record to assessment by the Association, including contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities which hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment by the Association.

### ARTICLE VI VOTING RIGHTS

The Association shall have one class of voting membership. All members shall be Lot owners, and shall be entitled to one vote for each Lot owned. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for each Lot shall be exercised as they determine, but in no event shall more than one vote be cast with respect to any Lot.

### ARTICLE VII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board consisting of nine (9) Directors, who must be members of the Association, and who shall be elected by vote of the membership of the Association. The principal officers of the Board shall be the President, Vice-President, Secretary, and Treasurer, and shall be elected by the Board. The remaining members of the Board shall serve at-large. At the annual meeting of the Association, the members shall elect nine (9) Directors, on a staggered basis, for a term not less than one (1) year nor more six (6) years, but the Directors may be re-elected for successive terms. A quorum of the Board consists of a majority of the Directors in office immediately before a meeting begins.

# ARTICLE VIII DISSSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of the members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

# ARTICLE IX DURATION

The corporation shall exist perpetually.

# ARTICLE X AMENDMENTS

Amendment of these Articles shall require the assent of seventy-five (75%) of the entire voting membership.
